

CERTIFIED CORNER RECORDATION

Corner WC CC 2 ES 1252 T. 36 N. R. 26 W. P.M.M. LINCOLN County

- I. Record: 1893 Subdivision and Meanders of T36N. R26W. by Peter M. Cardell and Abraham L. Jaqueth:
1933 U. S. Forest Service Exchange Survey No. 1252 by A. O. Modlin: Point at top of steep, sliding bank, which I establish for W. C. to cor. No. 2 and closing cor. of this survey as follows:

Place a small stone marked with a cross (X) under granite stone 26x14x12 ins., 16 ins. in the ground, marked W C C C 2 E S 1252 on the SE. face, and a cross (X) on top for the exact cor. point, from which

A cross (X) on a Douglas fir 18 ins. dia. bears S11°35'W 22 lks. dist. marked W C C C 2 E S 1252 BT.

A cross (X) on a Douglas fir 26 ins. dia. bears S47°10'W 23 lks. dist., marked W C C C 2 E S 1252 BT.

Raise a mound of earth 4 ft. base, 2 ft. high. SE. of corner.

- II. Found a stone 11x15 ins., 12 ins. above ground, firmly set and clearly marked W C C C 2 ES 1252 on SE face and an "X" on top, from which:

A fir, 13 ins. diam, bears S12°W, 15.2 ft. dist., mkd. with a healed face. (Rec. 14.5 ft.)

A fir, 24 ins. diam, bears S47°W, 16.5 ft. dist., mkd. W C C C 2 ES 1252 BT. (Rec. 15.2 ft.)

- III. Painted red the scribed face and a red band around the bearing trees.

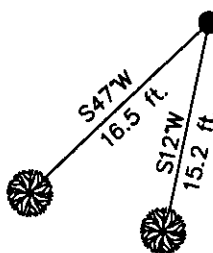

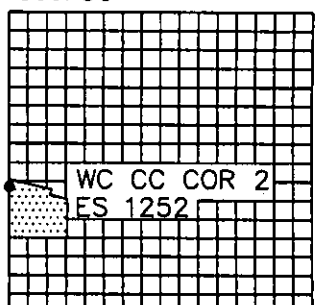
