
CERTIFIED CORNER RECORDATION

Corner CS 1/16 Sec. 22 36N 27W P.M., MT Lincoln County

- 1984 Certificate of Survey No. 1268 by Charles W. Doyle, No. 2516 S: Set I. a 5/8 in. x 24 in. rebar with plastic cap, stamped "2516 S".
- II. Found a 5/8 in. diam. rebar, firmly set, protruding 3 ins. above the ground, with a 1 1/4 in. diam. yellow plastic cap, stamped "Doyle 2516 S". No bearing trees found.
- III. Accepted the position of the found rebar, and set a 3/4 in. diam. x 30 ins. long aluminum rod, 27 ins. in the ground, with a 3 1/4 in. diam. aluminum cap, surrounded by a small collar of stone, mkd. as shown:




Established two bearing trees and one post:

A fir, 12 ins. diam., bears S62°W, 27.5 ft. dist., mkd. "CS 1/16 S22 BT". A fir, 14 ins. diam., bears S50°E, 89.9 ft. dist., mkd. "CS 1/16 S22 BT".

A 6 ft. steel guard post, South, on property line, 2.0 ft. dist. from the corner.

Drove the found rebar flush with the ground, next to the aluminum rod. Painted bearing trees and attached Land Survey Monument and Bearing Tree signs. Attached Land Survey Monument and Property Boundary decals to the post. CONTANAS
