

INSTRUCTIONS

1. Original and/or subsequent record used to evaluate the corner position.
2. Description of evidence found, note discrepancies in the record, state method of establishing lost or obliterated corners.
3. Description of monument and accessories set to perpetuate the corner position.
4. Sketch or corner, show all pertinent data which can best be shown in a sketch example, corner marking, topography ties, position of accessories, etc.
5. Certification must be signed and sealed by Registered Land Surveyor in State of Montana.
6. Fill in Cross Index & Section Diagram at bottom of sheet.

- I. From original 1894 G.L.O. notes. Set Basalt Stone 16"x12"x6", 11" in ground for Closing Corner of Sections 3 & 4, marked C.C. on South with 3 grooves on East & West faces, from which:

A Pine 20" in diam. bears S.60°45'W., 63 lks.

A Fir 6" in diam. bears S.44°E., 18 lks.

- II. Found Brass cap on iron pipe, B.L.M.

Found Pine snag, 20" bears S.60°45'W., 41.6 ft.

Found Stump hole, bears S.44°E., 11.9 ft.

Found 8" Pine, bears S.25½°E., 36.97 ft.

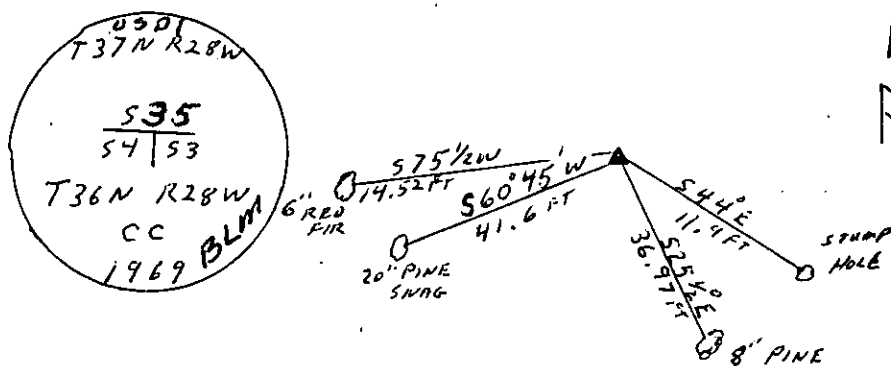
Found 6" Red Fir, bears S.75½°W., 14.52 ft.

- III. Set rock cairn around Mon.

- I-A. B.L.M. re-mon., June, 1969: Set 2½" I.P. w/Brass cap, 24" in ground.

S.4 B.T., 6" Fir, bears S.75½°W., 22 lks.

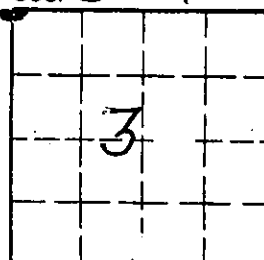
