

INSTRUCTIONS

1. Original and/or subsequent record used to evaluate the corner position.
2. Description of evidence found, note discrepancies in the record, state method of establishing lost or obliterated corners.
3. Description of monument and accessories set to perpetuate the corner position.
4. Sketch or corner, show all pertinent data which can best be shown in a sketch example, corner marking, topography ties, position of accessories, etc.
5. Certification must be signed and sealed by Registered Land Surveyor in State of Montana.
6. Fill in Cross Index & Section Diagram at bottom of sheet.

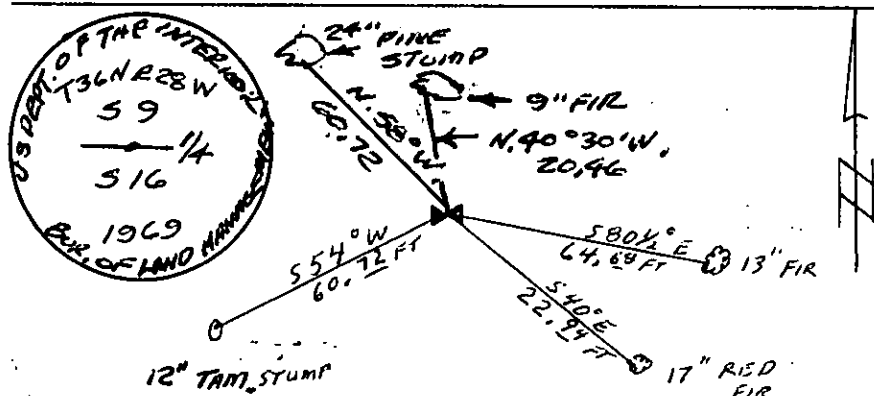

- I. From original G.L.O. 1894 notes: Set Limestone 18"x10"x7", 12" in ground, mkd. 1/4 on North Face from which:
 An 8" Tamarack bears S.54°W., 92 lks.
 A 24" Pine bears N.58°W., 92 lks.
 (SEE NOTE I-A)

- II. Found B.L.M. Brass Cap on Iron Pipe, found Orig. Stone North side of Mon.
 Found 12" Tamarack Stump bears S.54°W., 60.72 ft.
 Found 24" Pine Stump bears N.58°W., 60.72 ft.
 Found New B.T.s:
 A 9" Fir bears N.40 1/2°W., 20.46 ft.
 A 13" Fir bears S.80 1/2°E., 64.68 ft.
 Found 17" Red Fir bears S.40°E., 22.94 ft.

- III. Set Rock Cairn around Mon.
 Set 54-3 tag on 17" Red Fir (no info. on tag found).

- I-A. B.L.M. re-mon., June, 1969: Set 2 1/2" I.P. w/Brass cap, 24" in ground.
 S.9 B.T., 7" Fir, bears N.40 1/2°W., 31 lks.

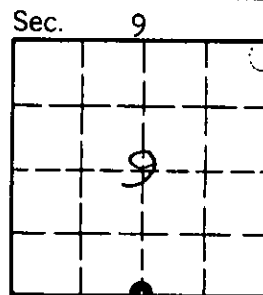
