

INSTRUCTIONS

1. Original and/or subsequent record used to evaluate the corner position.
2. Description of evidence found, note discrepancies in the record, state method of establishing lost or obliterated corners.
3. Description of monument and accessories set to perpetuate the corner position.
4. Sketch or corner, show all pertinent data which can best be shown in a sketch example, corner marking, topography ties, position of accessories, etc.
5. Certification must be signed and sealed by Registered Land Surveyor in State of Montana.
6. Fill in Cross Index & Section Diagram at bottom of sheet.

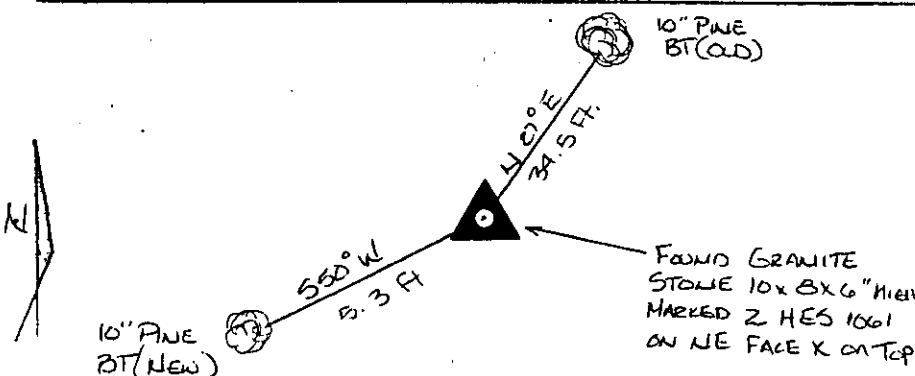
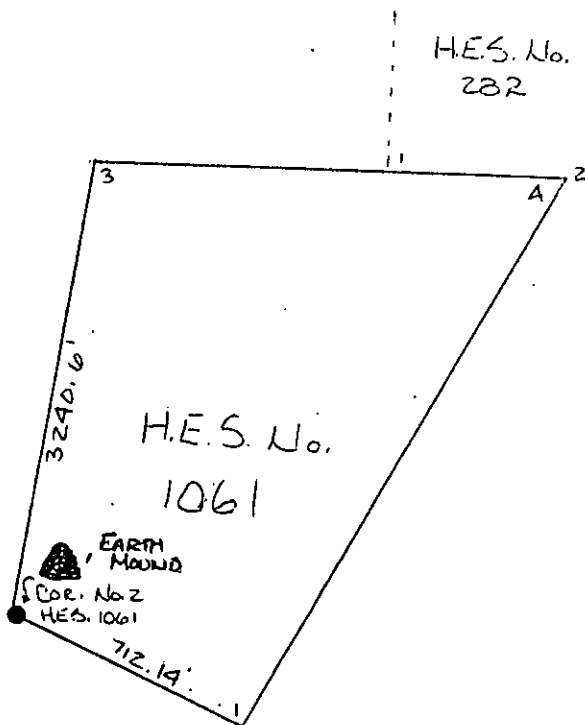

Record:

Cor. # 2 H.E.S. # 1061. Place a small stone, marked with a cross (x) under a granite stone, 24 X 10 X 8 inches, 14 inches in the ground, marked 2 H.E.S. 1061 on N.E. face and a cross (x) on top for the exact corner point from which,
A cross (x) on a black Pine tree, 5 inches diameter, bears N.27°10'E., 52 links distance.
A cross (x) on a Spruce tree 4 inches diameter bears S.29°35'W., 4 links distance, each blazed and scribed 2 H.E.S. No. 1061 BT.

Raise a mound of earth, 4 foot base 2 feet high, N.E. of corner.
Found: Granite stone 10" X 8" X 6" high marked 2 H.E.S. 1061 on N.E. face with an X on top.
from which
A 10" Pine bears N 27°E 34.5 feet scribing partially legible.
Posted.

Set: 10" Pine bears S 50°W 5.3 feet scribed 2 H.E.S. 1061 B.T. and posted.
Painted monument and accessories with bright red paint.
