

## INSTRUCTIONS

1. Original and/or subsequent record used to evaluate the corner position.
2. Description of evidence found, note discrepancies in the record, state method of establishing lost or obliterated corners.
3. Description of monument and accessories set to perpetuate the corner position.
4. Sketch or corner, show all pertinent data which can best be shown in a sketch example, corner marking, topography ties, position of accessories, etc.
5. Certification must be signed and sealed by Registered Land Surveyor in State of Montana.
6. Fill in Cross Index & Section Diagram at bottom of sheet.

## CERTIFIED CORNER RECORDATION

Corner W. 1/4 Sec. 14 T. 37N. R. 28W. P.M.M. Lincoln County

I. From original 1894 G.L.O. notes: Set a post 3' long, 3" square, marked 1/4 on West face, from which:

A Tamarack 16" in diam. bears N.35°30'W., 26 lks.

A Tamarack 8" in diam. bears N.23°15'E., 37 lks. (SEE NOTE I-A)

II. Found 1969 B.L.M. Brass capped Mon.

Found 12" Tamarack stump, bears N.23°15'E., 24.42 ft., visible scribing.

Found 16" Tamarack stump (appears to be Pine), bears N.35°30'W., 17.16 ft., visible scribing.

Found 8" Tamarack, bears N.48°W., 12.54 ft.

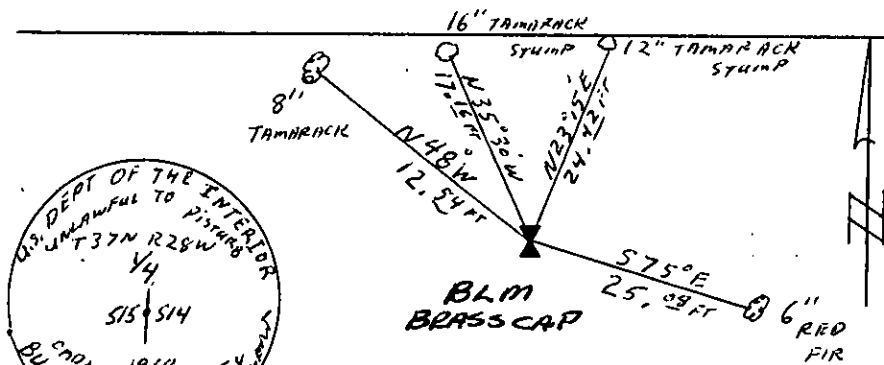
Found 6" Red Fir, bears S.75°E., 25.08 ft.

III. Put rock cairn around Mon.

I-A. B.L.M. re-mon., August, 1968: Set 2 1/2" I.P. w/Brass cap, 24" in ground.

S.14 B.T., 5" Fir, bears S.75°E., 38 lks.

S.15 B.T., 7" Larch, bears N.48°W., 19 lks.

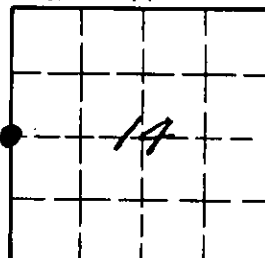
