

INSTRUCTIONS

1. Original and/or subsequent record used to evaluate the corner position.
2. Description of evidence found, note discrepancies in the record, state method of establishing lost or obliterated corners.
3. Description of monument and accessories set to perpetuate the corner position.
4. Sketch or corner, show all pertinent data which can best be shown in a sketch example, corner marking, topography ties, position of accessories, etc.
5. Certification must be signed and sealed by Registered Land Surveyor in State of Montana.
6. Fill in Cross Index & Section Diagram at bottom of sheet.

CERTIFIED CORNER RECORDATION

Corner S.E. Cor. Sec. 26 T. 37N. R. 28W. P.M.M. Lincoln County

I. From original 1894 G.L.O. notes: Set a post 4' long, 4" square, with marked stone 12" in ground, from which:

A 9" Cottonwood bears N.58 3/4°E., 18 lks.

A 7" Cottonwood bears S.70 3/4°W., 22 lks.

A 8" Cottonwood bears N.67 3/4°W., 22 lks.

(SEE NOTE I-A)

II. Found C.O.E. Brass Cap set in concrete flush with ground.

Found stump hole with parts of Cottonwood with scribing visible, bears S.70°45'W., 14.5 ft.

III. Placed Rock Cairn around Mon.

Set 22" Tamarack bears N.22°E., 7.6 ft., not scribed due to wire and fence brace attached.

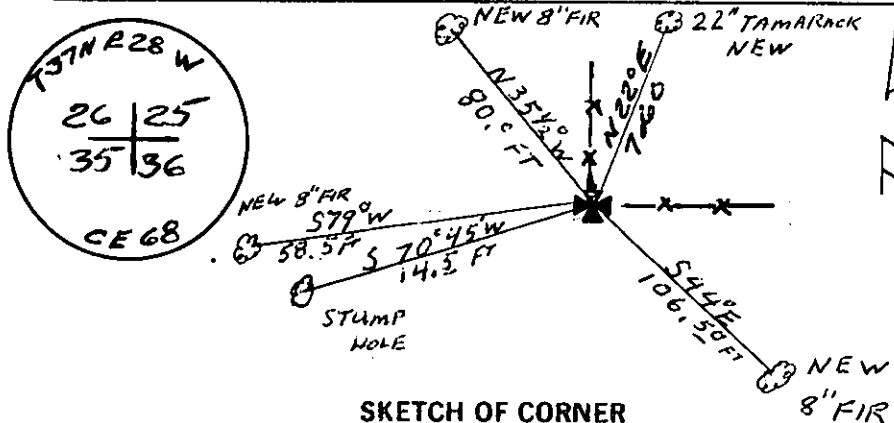
Set 8" Fir bears S.44°E., 106.5 ft., mkd. T37N R28W S36 B.T.

Set 8" Fir bears S.79°W., 58.5 ft., mkd. T37N R28W S35 B.T.

Set 8" Fir bears N.35 1/2°W., 80 ft., mkd. T37N R28W S26 B.T.

I-A. C.O.E. re-mon., 1969: Set I.P. w/Brass cap.

S.35 B.T., 30" Pine, bears S.59 1/4°W., 37 lks.

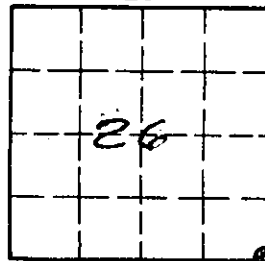
