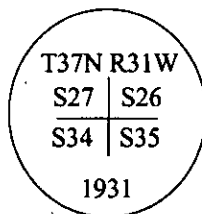


CERTIFIED CORNER RECORDATION

Corner SW SEC. Sec. 26 T. 37N R. 31W P.M., MT Lincoln County

- I. 1931 original G.L.O. record by Ranney Y. Lyman: Set an iron post, 3 ft. long, 2 ins. diam., 28 ins. in the ground, for corner of sections 26, 27, 34, and 35, with a brass cap mkd:



from which:

- A pine, 5 ins. diam., bears N 42 1/2°E, 55 lks. dist., mkd. "T37N R31W S26 BT".
- A tamarack, 12 ins. diam., bears S 20 3/4°E, 55 lks. dist., mkd. "T37N R31W S35 BT".
- A pine, 5 ins. diam., bears S 37 1/2°W, 31 lks. dist., mkd. "T37N R31W S34 BT".
- A tamarack, 15 ins. diam., bears N 28°W, 44 lks. dist., mkd. "T37N R31W S27 BT".

- II. Found an iron pipe, 2 ins. diam, firmly set, with a brass cap, 2 1/2 ins. diam, 10 ins. above the ground, mkd. as shown above.

from which:

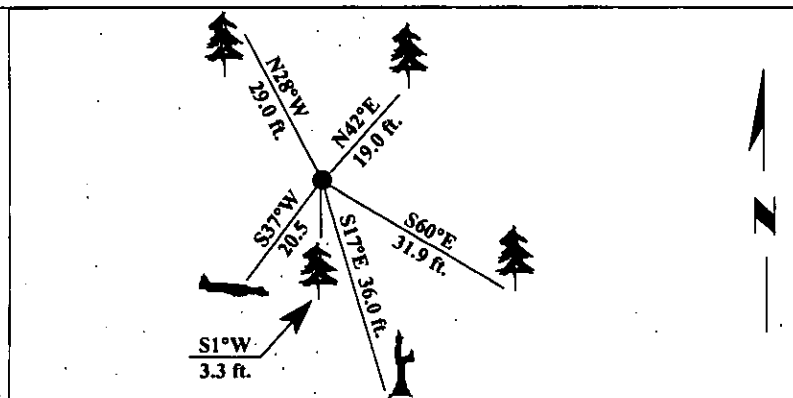
- A pine, 10 ins. diam., bears N 42°E, 19.0 ft. (29 lks.) dist., with visible scribing. (Rec. 55 lks.)
- A larch snag, 11 ins. diam., bears S 17°E, 36.0 ft. (55 lks.) dist., with visible scribing. (Rec. S 20 3/4°E)
- A rotten log, bears S 37°W, 20.5 ft. (31 lks.) dist., with no visible scribing.
- A larch, 17 ins. diam., bears N 28°W, 29 ft. (44 lks.) dist., with visible scribing.

- III. Established 2 new bearing trees:

- A fir, 11 ins. diam., bears S 60°E, 31.9 ft. dist., mkd. "T37N R31W S35 BT".
- A larch, 9 ins. diam., bears S 1°W, 3.3 ft. dist., mkd. "T37N R31W S34 BT".

Painted bearing trees and attached Land Survey Monument and Bearing Tree signs.

Magnetic Declination: 20° East.
