


- International Feet. 5) The lot is contiguous and contains no gaps, gores, or overlaps, however Plat 2076 did not represent U.S. Highway 2 right-of-way correctly as shown on Right of Way Plan of Federal Aid Project No.
- 6) Found 2" aluminum cap (Morrison-Maierle 14388ES) near northeasterly corner of Plat 2076, however not on U.S. Highway 2 right-of-way. Monument bears N.24°29'03"E., 7.13 feet from true position, monumented with a yellow plastic cap (COLLINS 18626LS)
- 7) Found red plastic cap (9958LS) on rebar which appears to have been a faithful retracement of Plat 2076, however does not land on Highway 2 right-of-way. Accepted monument for east right-of-way of Education Way, but extended said east right-of-way northerly to intersect the south right-of-way of Highway 2. Monument bears S.04°22'16"E., 5.98' from true position, monumented with a yellow
