RESOLUTION 2023-33

A RESOLUTION OF INTENT TO DISSOLVE THE TROY AREA DISPATCH DISTRICT AND PERMANENTLY TRANSFER DISPATCH SERVICES TO LINCOLN COUNTY SHERIFF'S OFFICE

THE BOARD OF COUNTY COMMISSIONERS FOR LINCOLN COUNTY, MONTANA FINDS:

WHEREAS, the Lincoln County Board of Commissioners received approved Resolution 2023-09-22 from Troy Area Dispatch District Board requesting the dissolution of Troy Area Dispatch District, permanently transferring dispatch services to Lincoln County Sheriff's Office.

WHEREAS, the Lincoln County Sheriff's Office has provided uninterrupted emergency dispatch services to the Troy Area Dispatch District since July 17, 2023, and has declared that the Lincoln County Sheriff's Office is willing and able to continue to provide uninterrupted emergency dispatch services to the Troy Area Dispatch District in perpetuity.

1. Pursuant to 7-11-1029 MCA, the Board of County Commissioners is granted the power and authority to dissolve a special district if it is considered to be in the best interest of a local government or the inhabitants of the local government or if the purpose for creating the special district has been fulfilled and the special district is not needed in perpetuity.
2. It is the intent of the Lincoln County Board of Commissioners to dissolve the Troy Area Dispatch District and transfer its services to the Lincoln County Sheriff's Office effective immediately.
3. Lincoln County maintains an assessment detail by district which contains information about all parcels taxed under the Troy Area Dispatch District. 7-11-1014 MCA.
4. Pursuant to MCA 7-11-1029; attached boundary map(s) of the district which consists of Troy high School District No. 1;

THE BOARD RESOLVES:

To approve Resolution 2023-33 Intent to Dissolve the Troy Area Dispatch District and Permanently Transfer Dispatch Services to Lincoln County Sheriff's Office.

1. That dissolution is in the best interest of Lincoln County and the inhabitants of the district;
2. That the purpose for creating the Troy Area Dispatch District has been fulfilled and the Troy Area Dispatch District is not needed in perpetuity.
3. The Board of County Commissioners shall proceed to hear and pass upon all protests so made a public hearing on Wednesday October 18, 2023, at 6:00 PM at Troy City Hall, City Council Chambers 310 E. Kootenai Ave. Troy, MT 59935. During this hearing, the Board of County Commissioners will hear and consider all public comments and written submissions both in support of and against the dissolution of the Troy Area Dispatch District.
4. Pursuant to 7-1-2021 MCA the Lincoln County Clerk and Recorder shall publish a notice of the hearing in the Western News twice, the week of October 6th and again October 13th, 2023.

THE BOARD FURTHER RESOLVES:

1. If a provision of this resolution conflicts with a provision of a previously adopted resolution, this resolution will prevail.
2. This resolution and its various sections, clauses and paragraphs are severable. If any part, sentence, clause, or phrase is adjudged to be unconstitutional or invalid, the remainder of the resolution will not be affected.
3. This resolution will be effective immediately upon adoption, in accordance with § 7-5-123, MCA.
4. This Board directs that this resolution be entered into the minutes and signed by the Chair of the Board in accordance with § 7-5-121, MCA.

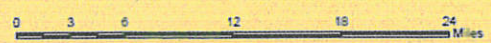
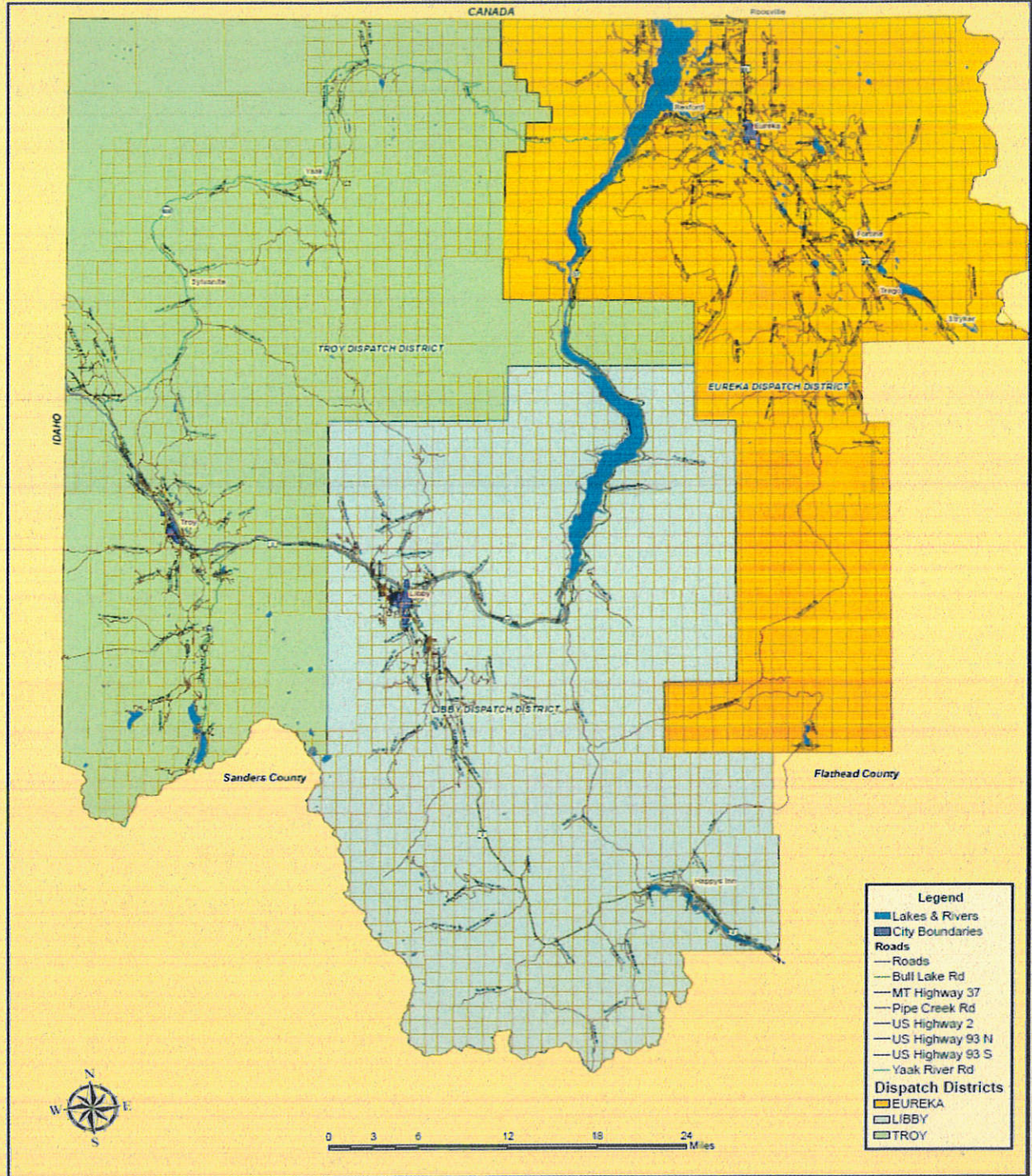
