RESOLUTION 2023-35

RESOLUTION TO AMEND TROY TV DISTRICT FEE SCHEDULE

THE BOARD OF COUNTY COMMISSIONERS FOR LINCOLN COUNTY, MONTANA FINDS:

1. The Lincoln County Board of Commissioners created the Troy TV District under MCA 7-11-1004.
2. On August 24, 2023, the Board of County Commissioners received a formal request from the Board of Directors of the Troy TV District to amend the fee schedule, effective November 30th, 2023, as follows:

PRESENT FEE	PROPOSED FEE
\$15 / year	\$25 / year

3. The Lincoln County Board of Commissioners passed Resolution 2023-28 dated August 30, 2023. A Resolution of Intent to Amend the Troy TV District Fee Schedule.
4. A Public Notice was issued pursuant to MCA 7-1-2121.
5. A Public Hearing was held October 4, 2023, at 11AM in Room 108 of the Lincoln County Courthouse, 512 California Ave. Libby, MT 59923 for the purpose of public comment for or against the fee schedule amendment as set forth above.
6. The Lincoln County Board of Commissioners has considered all comments and has concluded that the amendment to the fee schedule of the Troy TV District should be adopted as set forth above.

THE BOARD RESOLVES:

The Lincoln County Board of Commissioners hereby officially approves the fee schedule rates for the Troy TV District, in accordance with MCA 7-11-1024, as detailed above.
