BUDGET AMENDMENT

THE BOARD OF COUNTY COMMISSIONERS FOR LINCOLN COUNTY, MONTANA FINDS:

1. The Lincoln County Board of Commissioners did approve the budget for Lincoln County during the regular budget meeting for the 2022/2023 budget.
2. The original revenue and expenditures did not include funds that have been received from sources not known at the time of the budget approval and/or expenses not known at the time of budget approval.
