Overview

A Community Health Improvement Plan (CHIP) is a community-based systems approach to address public health issues identified through a Community Health Needs Assessment (CHNA). The Lincoln County CHNA was completed in 2023 as part of a collaborative effort between Lincoln County Health Department, Cabinet Peaks Medical Center and Northwest Community Health Center. See the CHNA for a full report.

The following were the priority areas determined by the CHNA:

- Access to care
- Social determinants of health
- Healthy lifestyles

The planning committee developed the Community Implementation Plan (IP) to create community level goals, strategies and activities to address priority areas. See Implementation Plan (2023-2026) for details and full plan.

This Improvement Plan breaks down the goals and strategies in the IP to develop more specific activities for the health department to achieve to address the priorities areas from the CHNA and the goals and strategies from the IP. The specific references to the IP are listed in each activity. This plan is intended to be used in conjunction with the IP.

Implementation and Tracking

The CHNA and IP are completed every 3 years. The next Lincoln County CHNA will be completed in 2026. During the next 3 years, this Improvement plan will be reviewed quarterly at Health Department staff meetings to assess progress towards improvement in each area. Progress will be shared through the Department Annual Report. Progress will be measured through the target and measures.
