The Lincoln County Board of Commissioners met for a regular session on June 15, 2022 in the Lincoln County Annex, Eureka, Montana. Present were Commissioner Teske, Commissioner Letcher, Commissioner Bennett, County Administrator Jim Hammons and Clerk and Recorder Robin Benson.

Meeting allows for teleconferencing and VisionNet availability.

Commissioner Bennett opened the meeting with the Pledge of Allegiance and Prayer.

9:15 AM Recreational Marijuana Excise Tax/City of Libby: Present were Dianne Hansen, Ray Stout, Kathleen Sheffield, Rebecca Nelson and Solomon Alcain.

Commissioner Bennett explained the county did receive a letter from the City of Libby expressing that county governments are authorized by resolution to initiate a ballot of county electors concerning the question of applying a tax on the retail value of marijuana and marijuana products sold as Adult-Use Dispensary or Medical Marijuana Dispensary, capped at 3%. The City of Libby requests that the commission approve a resolution initiating a ballot as described with a rate of 3% to be conducted by a special mail ballot election. The City of Libby agrees to participate in the cost of a mail ballot election on this question.

Commissioner Bennett expressed the county should follow in the same way. Any revenue received would go to law enforcement or mental health services. Commissioner Bennett will follow up with Robin about preparing a resolution.

10:00 AM Planning-Final Plat Approval Downing Subdivision/Final Plat Approval One Up Subdivision: Present were Planning Consultant Kristin Smith, County Planner Jesse Haag, Byron Sanderson, Dianne Hansen, Solomon Alcain, Ray Stout and Rebecca Nelson.

Kristin commented that both final plats have been reviewed and were approved earlier this year.

- Final Plat One Up Subdivision: 2 lots in Eureka area, all 9 conditions of approval have been met. Planning staff
  recommends commissioners to approve final plat. Motion by Commissioner Letcher to approve final plat for One
  Up Subdivision based on planning staff recommendation. Second by Commissioner Teske, motion carried
  unanimously.
- Final Plat Downing Subdivision: 2 lots in the Rexford area, all 7 conditions of approval have been met. Planning staff recommends commissioners to approve final plat. **Motion** by Commissioner Letcher to approve final plat of Downing Subdivision based on planning staff recommendation. Second by Commissioner Teske, motion carried unanimously.

10:15 AM ARP Update: Present were ARP Director Amanda Harcourt, Rebecca Nelson, Ray Stout, Solomon Alcain, and Tom Lane.

ARP Director Amanda Harcourt submitted and read the following report:

# Asbestos Resource Program (ARP) Report for Commissioner's Meeting

June 15th, 2022

10:15 - 10:30

In May, ARP received 23 hotline calls. 19 were from Libby, 4 from Troy. Most of the requests were for U.S. Environmental Protection Agency (EPA) comfort letter/MT Department of Environmental Quality (DEQ) status letter requests.

ARP also received 71 utility locate tickets from properties within the Superfund site in May: 61 from Libby, 10 from Troy.

ARP completed 22 site visits within May. Most of these site visits were to confirm digging locations for utility locates and to active asbestos abatement/sampling projects.

# ONGOING/PLANNED ABATEMENTS:

386 Riverside Drive, Troy – planned soil removal – on going; Work was tentatively scheduled Spring of 2022. ARP hasn't been able to contact the property owner to move forward with abatement activities since fall of last year. ARP was able to contact the property owner. She will be sending the signed SOW to ARP next week.

713 Michigan Avenue, Libby – planned indoor removal from residential building; waiting to hear from property owner about hiring a contractor.

42162 US Hwy 2, Libby- NOPEC- Property owner encountered Vermiculite Insulation falling out of the ceiling of an old outbuilding on the property. The property owner has hired an abatement contractor and the building has been demolished. ARP ran oversite during the demolition and all activities met EPA criteria for the removal.

757 E 5<sup>th</sup> St, Libby- Property is currently under contract to the perspective buyer. VCI was released on the East side of house, contaminating a large area of the side yard and a portion of the understructure. ARP has been in contact with the new property owner and will be drafting an abatement SOW when the property closes.

803 Minnesota Ave, Libby-While installing a new outlet the property encountered VCI. ARP conducted a site visit and confirmed the present of VCI within the wall cavity that the outlet was being installed. There was also a release of VCI in the basement where he was feeding electric to the new outlet. ARP is drafting a SOW for the abatement of the wall cavity and a spot clean a seal in the basement.

Asa Wood School, Libby-ARP contacted Ron Goodman (Superintendent of Schools) The Asa Wood building has been sold and work for the brownfield grant is scheduled to start July. The property owner has plans to demolish the west wing of the building after the regulated asbestos has been removed. The west wing is the main area of the structure containing VCI withing the CMU. ARP will be contacting the new property owner to discuss the property and timelines.

#### ONGOING/PLANNED SAMPLING:

GID 11192, Troy – Property was designated a non-use area during the time of investigation. The property has snice been developed. The sampling SOW has been finalized. The property owner will be soliciting an asbestos inspector to collect the soil samples at the property. ARP will be running oversite during sample collection.

287 Terrace View, Libby- ARP identified gross levels of VV on areas of the property where tree stumps had been removed. ARP conducted a second site visit, and the property owner is planning significant construction near the area where the stumps had previously been removed. ARP will be conducting oversite during his work activities to see if the SOW needs to be modified. Property owner is waiting on weather conditions to improve before starting construction activities.

288 Hummingbird Ln, Troy-NOPEC property. ARP was contacted by the property owner to draft a sampling SOW for the property. ARP will be conducting the interior inspections for the three structures on the property.

#### FUNDING

The ARP program is funded through a Memorandum of Agreement with DEQ. This is funding coming from a cooperative agreement between DEQ and EPA. The agreement designates \$600,000 over two years starting with costs from July 1st, 2020, until May 31st, 2022. Total costs incurred by ARP & reimbursed by DEQ since July 2020 is approximately \$549,700 leaving a remaining balance of \$50,300. The last reimbursement came in April. Claims for May reimbursement will be sent to DEQ on the 16th June.

Dianne commented that she has spoken to residents, and they all expressed they feel safe regarding vermiculite contamination.

10:30 AM Administrative Issues/Old Business: Present were Dianne Hansen, Ray Price, Rita Collins, Rebecca Nelson, Tom Lane and Solomon Alcain.

- Robin submitted the minutes for June 8 regular meeting for approval. Motion by Commissioner Teske to approve
  minutes as submitted. Second by Commissioner Letcher, motion carried unanimously. Robin thanked County
  Administrator Jim Hammons for taking minutes in her absence.
- Commissioner Letcher said he had a phone interview with Kristin Omvig, of Rocky Mountain Law regarding water
  rights and suggested the county seek outside counsel to help citizens with water rights issues. Seeking permission
  to move forward with contract.
  - Commissioner Bennett suggested an MOU with the city's for the hours spent working with city residents or cities to contact Kristin themselves. Commissioner Bennett explained there is no concern with residential wells. **Motion** by Commissioner Teske to move forward with contract between Lincoln County and Kristin Omvig of Rocky Mountain Law for legal counsel, to be paid out of PILT. Second by Commissioner Letcher, motion carried unanimously. Commissioner Bennett clarified the reason is that federal agencies that have objected to private water rights on streams for use and we want to join and help defend this cause. We do not need more instream rights.
- Commissioner Letcher submitted an easement agreement between the Eureka School District and Lincoln County.
   J. Tiffin Hall wrote the easement. Commissioners agreed to sign the easement agreement.
- Ray submitted a quote for a front-end loader brusher boom attachement from John Deere of \$84,418.70. The cost
  is to be absorbed in the FY 22/23 road budget. Current loader is 30 years old and no longer working, nor can it be
  repaired.

10:45 AM **Public Comment Time**: Present were Janelle Kimberlin, Liz Voorhies, John Bursell, Jane Vass, Roxanne Escudero, Andy Escudero, Dianne Hansen, Rebecca Nelson, Ray Price, Rita Collins, Tom Lane and Solomon Alcain.

Janell Kimberlin commented that job service usually uses the Eureka Office for the job fair event which is this Friday from 11:00am to 1:00PM. There is more interest this year and Janell is asking to use the conference room for overflow during the event. Commissioner Letcher will check and ensure the room is not already reserved during that timeframe.

Andy said he is here to talk about getting potholes filled on Rustic Avenue between Vanderwood and Plummer. This is not really a street, but a 20' utility easement. Open to any suggestions including potentially closing the alley. None of the residents maintain the road/easement. It is private property not owned by county.

Commissioner Bennett explained it is a private road, utility easement, and to block it off would require a legal opinion from an attorney. It is not a county road. Previous owners agreed to a maintenance agreement in their deeds to contribute to road maintenance. Commissioner Bennett said he would have to ask the county attorney to give an opinion to determine if the county has any authority. There is a previous agreement that owners are responsible for the road maintenance. Andy said he did seek legal counsel and it was the attorney's opinion the road maintenance agreement cannot be enforced.

Commissioner Bennett commented that he personally has no issue with blocking it off, but would have get a legal opinion before they do that; its not a public matter, it's a private matter. There is other access available. Commissioner Bennett offered to check with the county attorney to render an opinion if the county can be involved. Commissioner Bennett invited Andy to come in to visit for further conversation.

Roxanne expressed the hardship is residents cannot even have their trash picked up because trucks get stuck in the holes. Roxanne submitted pictures indicating this is what we have to deal with every day.

Dianne asked about what the commissioners thought of the hand-count primary election.

Commissioner Bennett said Robin and Brent did not participate since they were on the ballot. Commissioner Bennett said he spent a lot of time helping and it went really well, but hopes we don't ever have to do it again. The entire state was waiting on Lincoln County for two close races, and we endeavor to not do that again. We are really blessed with volunteers to get the job done and it was a great job. Commissioner Bennett stated that he was really impressed and the accuracy in which they did it.

Dianne talked about a website IV3.us to help with voter rolls cleaning.

Robin explained that there is a legal process for moving active to inactive and cancelling electors in the election database that all Montana counties must adhere to. Robin encouraged Dianne to visit the Election Center to learn more about the process and legal requirements. No electors are cancelled from information on any website.

Commissioner Bennett commented that he looked at the number of undeliverable ballots and expressed the election department does a great job keeping the database clean and agreed with Robin to come in and visit with the election administrator to learn about the actual process.
