RESOLUTION TO ESTABLISH DAYS/HOURS OF OPERATION FOR COUNTY OFFICES

**THE BOARD OF COUNTY COMMISSIONERS FOR LINCOLN COUNTY,
MONTANA FINDS:**

WHEREAS, 7-4-102, M.C.A., gives the Board of County commissioners the authority to establish hours for county offices to be open and transact business, and

WHEREAS, it is the intent of the elected officials and the employees of Lincoln County to be available and serve the citizens of Lincoln County to the best of their ability, and

WHEREAS, subject to 7-4-2211 MCA, County offices. (1) All county officers, except justices of the peace as set forth in 3-10-101 and except as provided in subsection (3), must keep their offices at the county seat.

(2) (a) The sheriff, the county clerk, the clerk of the district court, the treasurer, the county attorney, the county auditor in counties in which that officer is maintained, and the county assessor shall keep their offices open for the transaction of business during the office hours determined by the governing body by resolution after a public hearing and only if consented to by any affected elected county officer, every day in the year except legal holidays and Saturdays.

THE BOARD RESOLVES:

That office hours for county offices listed above are from 8:00 a.m. to 5:00 p.m. Monday through Friday weekly except on legal holidays, and Saturdays. All offices with a sufficient number of employees to rotate lunch hours will remain open during the lunch hour (noon to 1:00 p.m.) except in the event of emergency or extenuating circumstances. Offices listed above with limited employees may close for 1 hour with signage indicating return time.

Lincoln County Sheriff's Office is an exception to this rule as they operate on a 24/7 basis.
