### A Resolution Establishing A Location for Posting Public Notice

**THE BOARD OF COUNTY COMMISSIONERS FOR LINCOLN COUNTY,  
MONTANA FINDS:**

**Whereas**, MCA § 7-1-2121 establishes requirements when public notice is to be provided by publication.

**Whereas**, MCA § 7-1-2122 establishes requirements when public notice is to be provided by mail.

**Whereas**, MCA § 7-1-2123 establishes requirements when public notice is to be provided by posting.

MCA 7-1-2123. Posting. (1) The governing body shall specify by resolution a public location for posting information and shall order erected a suitable posting board.

(2) When posting is required, a copy of the document must be placed on the posting board, and a copy must be available at the office of the county clerk and recorder.

### **NOW, THEREFORE, BE IT RESOLVED:**

Lincoln County hereby designates the following location(s) for public notice postings:

The bulletin boards near the SE and NE entrance on the main floor of the Libby Courthouse and the public bulletin board at the Eureka Annex in the main business office.
