A Resolution to Accept the Determination that An Environmental Impact Statement is not required for the proposed Yaak Community Hall Floor Rehabilitation Project

THE BOARD OF COUNTY COMMISSIONERS FOR LINCOLN COUNTY, MONTANA FINDS:

Whereas, Lincoln County, as acting fiscal sponsor for the Yaak Community Hall Board, and the Yaak Community Hall Board completed a review to identify potential environmental impacts to the Yaak Community Hall Floor Rehabilitation Project, which will provide stability to the exterior lower logs and floor within the Yaak Community Hall; and

Whereas, the draft Environmental Review Record was made available for public comment at a noticed public hearing held February 16th at 11 am at the Yaak Community Hall where comments were heard; and

Whereas, public comment was received and responded to; and

NOW, THEREFORE, BE IT RESOLVED:

The Lincoln County Board of Commissioners has determined that the Yaak Community Hall Floor Rehabilitation Project will not significantly affect the quality of the human environment and is categorically exempt from MEPA under ARM 8.2.328(2) because:

- 1. The proposed project does not substantially change the footprint of the building from existing conditions and is not increasing the population it can serve.
- 2. The proposed project will occur on US Forest Service Kootenai National Forest lands and the Yaak Community Hall Board will work with the Forest Service to consider environmental impacts under the National Environmental Policy Act.



THE BOARD FURTHER RESOLVES:

- 1. If a provision of this resolution conflicts with a provision of a previously adopted resolution, this resolution will prevail.
- 2. This resolution and its various sections, clauses and paragraphs are severable. If any part, sentence, clause, or phrase is adjudged to be unconstitutional or invalid, the remainder of the resolution will not be affected.
- 3. This resolution will be effective immediately upon adoption, in accordance with § 7-5-123, MCA.
- 4. This Board directs that this resolution be entered into the minutes and signed by the Chair of the Board in accordance with 7-5-121, MCA.
