### A Resolution To Set Elected Official Base Salaries

#### THE BOARD OF COUNTY COMMISSIONERS FOR LINCOLN COUNTY, MONTANA FINDS:

**Whereas,** Pursuant to 7-4-2503 MCA and MCA 7-4-2504 Salary schedule of certain county officers- compensation board and Salaries to be fixed by resolution -- cost-of-living increments, the Lincoln County Compensation Board of Commissioners did approve a motion to award a 1.5% COLA increase to all elected officials effective July 1, 2024; and

#### THE BOARD RESOLVES:

To establish base salaries for elected official, as verified by human resources department, at the following rates effective July 1, 2024.

Superintendent of Schools	63,166.43


