A qualified registered elector who will be absent from the district during the time the election is being conducted may: a) vote in person in the Election Office as soon as the ballots are available and until noon the day before the ballots are scheduled to be mailed; b) make a written request, signed by the applicant and addressed to the election administrator, that the ballot be mailed to an address other than the address that appears on the registration card.

If you miss the regular registration deadline (April 8<sup>th</sup>, 2024), you may still register for the election by showing up at the Election Office by noon on the day before election day.
