### A Resolution of the County Commission of Lincoln County Montana, Declaring Election by Acclamation 2024

#### THE BOARD OF COUNTY COMMISSIONERS FOR LINCOLN COUNTY, MONTANA FINDS:

**Per MCA 13-1-403 (4)** Except as provided in subsection (5)(b) and unless otherwise specifically provided by law, if the number of candidates filing for election is equal to or less than the number of positions to be filled, the election administrator shall notify the governing body of the local government in writing that the election is not necessary and the governing body may by resolution cancel the election.

**Whereas,** the Lincoln County Commission is the governing body of County of Lincoln; and

**Whereas,** the Election Administrator has notified the governing body in writing that the election is not necessary.
