PURPOSE OF SURVEY

The purpose of this survey is to retrace the exterior boundaries of an existing tract of record and no new parcels have been created; therefore, this survey is exempt from review as a subdivision being completed pursuant to 76-3-404 M.C.A.

DESCRIPTION OF PARCEL A

A tract of land near Libby, Lincoln County, Montana, located in Gov't Lot 4 of Section 4, Twp. 30 N., R. 31 W., P.M.M., being Plat 968 and Tract A of C.O.S. 2790 and Tract A of C.O.S. 2839, containing 3.82 acres more or less and more particularly described as follows:

Beginning at a 5/8 inch dia. rebar capped MDL 4232S, marking the northeasterly corner of Plat 968 and the northerly corner of Parcel A of C.O.S. 2790 located on the North line of Section 4, Twp.30N., R.31W., P.M.M.; thence, leaving the North line of said Section 4, S9°20'46"W 141.02 feet to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence, S13°09'46"W 106.93 feet to a bare 5/8 inch dia. rebar; thence, S1°44'15"W 54.58 feet to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence, S82°39'50"E a total distance of 99.98 feet to a computed point on the centerline of Parmenter Creek; thence, upstream along said centerline of Parmenter Creek one (1) course S38°52'57"W 27.98 feet to a computed point; thence, leaving said centerline of Parmenter Creek N79°31'29"W a total distance of 103.50 feet to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence, N89°07'24"W 81.02 feet to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence, S89°45'08"W 405.44 feet to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence, N0°08'19"E a total distance of 311.55 feet to a computed point located on the North line of said Section 4; thence, along the North line of said Section 4, N89°44'22"E a total distance of 554.79 feet to the point of beginning.

Beginning at a 5/8 inch dia. rebar capped K.E.D. 4975-S, marking the northeasterly corner of Tract 3BB and the northwesterly corner of Parcel B of C.O.S. 1076; thence, S0°18'46"W a total distance of 378.97 feet to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence, N89°42'48"E a total distance of 332.01 feet to a bare 5/8 inch dia. rebar; thence, N0°21'50"E 439.58 feet to a computed point on the centerline of Parmenter Creek; thence, upstream along said centerline of Parmenter Creek the following three (3) courses S78°59'37"W 100.95 feet to a computed point; thence, S38°52'57"W 53.02 feet to a computed point; thence, S38°52'57"W 27.89 feet to a computed point; thence, leaving said centerline of Parmenter Creek, N79°31'29"W a total distance of 103.50 feet to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence, S89°07'24"E 81.02 feet to the point of beginning.




DESCRIPTION OF PARCEL C

The aforedescribed Parcel C contains 3.52 acres more or less and and is subject to and together with all appurtenant easements of record.




