

SURVEYOR'S NARRATIVE

The purpose of this survey was to delineate the boundary of the property owned by Investment Foundation, LLC, lying South of Highway No. 508 in the E1/2 of the

of Section 26, T33N, R34W, P.M.M. The property was bisected by the existing County Road. The right of way of the County road was determined to be 60 feet based on that right of way deed from A.S. Wise and his wife, Hattie R. Wise to Lincoln County recorded July 29, 1918 as Reception No. 9346. The Highway right of way was determined based on Highway plans dated 1964 and found right of way

Research was also conducted regarding the status of what is known as Goathead Road. This road is now considered a private road, but based on County mapping and onginal deeds to A.S. Wise it was determined that Goathead Road was previously

GPS and conventional survey equipment was utilized to complete the survey. The bearings and coordinate system were based on Montana State Plane with a Scale Factor of .9996615 and the survey was rotated based on a convergence


