
LEGAL DESCRIPTION: PARCEL B

Commencing at the northeast corner of Parcel B, COS No. 2265, a 5/8 inch diameter rebar with plastic cap marked MARQUARDT, 7328S, and the TRUE POINT OF BEGINNING; Thence along the northeasterly boundary of said Parcel B, N59°12'34"W, 357.07 feet to a 5/8 inch diameter rebar with plastic cap marked MARQUARDT, 7328S; Thence along the west boundary of said Parcel B, S36°14'40"W, 75.02 feet to the northeast corner of Parcel A, COS No. 4170RB, a 5/8 inch diameter rebar with plastic cap marked ERICKSON, 15272LS; Thence along the north boundary of said Parcel A, N52°15'54"W, 271.48 feet to a 5/8 inch diameter rebar with plastic cap marked ERICKSON, 15272LS; Thence continuing along said north boundary of Parcel A, N70°57'15"W, 52.68 feet to the easterly right-of-way limit of Montana Highway 37, a 5/8 inch diameter rebar with plastic cap marked ERICKSON, 15272LS; Thence along said right-of-way limit, along a 1383.24 foot radius curve to the left, 374.25 feet arc distance through a delta angle of 15°30'07" to a 4x4 concrete highway right-of-way monument; Thence S44°56'48"E, 796.60 feet to a 5/8 inch diameter rebar with blue plastic cap marked SANDERSON, 70400LS; Thence S00°00'00"E. 97.00 feet to the northeast corner of Parcel B, COS No. 2265, a 5/8 inch diameter rebar with plastic cap marked MARQUARDT, 7328S and the TRUE POINT OF BEGINNING, containing 3.50 acres. Pursuant to MCA 76-3-207(5): "An immediate family member or the spouse of an immediate family member who receives a division of land pursuant to subsection (1)(b) or (2)(b) may not transfer or otherwise convey the division of land for a period of up to 2 years after the date of the division unless the governing body sets a period of less than 2 years. A governing body may authorize variances from these requirements to address hardship situations."





PURPOSE OF SURVEY AND CERTIFICATION

I, <u>Eric W. Patton</u>, record owner, hereby certifies that the purpose of this survey and division of land is to transfer Parcel B to my son, *Tell Patton*, and that this is the first and single gift or sale in this county to this member of my immediate family. Therefore, this division of land is exempt from review as a subdivision pursuant to M.C.A. 76-3-207(1)(b). I also certify that Parcel A is 20 acres or greater, exclusive of public roadways, and is therefore not subject to sanitation review by the DEQ pursuant to MCA 76-4-102(24). I further certify that Parcel B is exempt from sanitation review pursuant to MCA 76-4-104(7)(p): "a basis for exempting from review facilities previously approved under this chapter or by a local reviewing authority of the facility is not proposed to be changed, is not affected by a proposed change to another facility, and meets the design conditions of its existing approval under this chapter or by the local authority and is operating properly. Existing systems must meet the current setbacks established in rule and subsection (7)(i), unless the lot was created before the relevant effective dates for mixing zones and isolation zones."

METHOD OF SURVEY

A Trimble R10 Model 2 GNSS System was used to tie previously set controlling corners by Calen Williamson February, 2024.

BASIS OF BEARING AND VARIATION

The basis of bearing for this survey is true north based on a static GNSS system observation. Angular variation between this survey and COS No. 1593 is 04°12'22" along the south boundary of the NE1/4 NE1/4 of Section 22.

Note: Many previous surveys in this area utilized bearings derived from USACE Libby Dam Project data which referenced the Montana State Plane (MSP) horizontal datum. This accounts for the large angular variation between some record and found measurements shown hereon, as the MSP contains a north convergence angle of approximately 4°30' east of true north in this area.
