INVITATION TO BID

Separate sealed bids for construction of the Lincoln County Landfill Expansion will be received by Lincoln County Clerk and Recorder's office at 512 California Ave, Libby, MT 59923 until 4:00 p.m. local time on Tuesday, February 18, 2025, and then publicly opened and read aloud at the Commission meeting at 66121 Hwy 37 Eureka, MT 59917 at 10:30 a.m. local time on Wednesday, February 19, 2025.

The project consists of the construction of the Landfill Expansion Cell within the licensed landfill area. The 14.6-acre landfill cell will include excavation, embankment, and preparation of the liner subgrade and will be lined with the liner system shown on the plans. The liner system includes the following elements from bottom to top: Compacted native liner subgrade, 60 Mil. Double-sided textured HDPE flexible membrane liner, non-woven geotextile fabric, gravel base drainage and protective layer. A portion of the landfill cell will include a reinforced landfill cover as shown on the plans. The project will also include leachate collection, outfall piping, and leachate pond lining. The project includes the construction of an access road, stormwater pond, fencing, and miscellaneous drainage improvements. The project also includes using some of the excavated material as an earthen closure cap over the existing landfill.

There will be a Pre-Bid Conference at the office of Lincoln County Commissioners at 512 California Ave, Libby, MT 59923, on February 6, 2025, at 10:00 a.m. local time. Interested Contractors are encouraged to attend.

Contractor and any of the Contractor's Subcontractors bidding or doing work on this project will be required to be registered with the Montana Department of Labor and Industry (DLI). Forms for registration are available from the Department of Labor and Industry, PO Box 8011, 1805 Prospect, Helena MT 59604-8011. Information on registration can be obtained by calling (406) 444-7734. All laborers and mechanics employed by Contractor or Subcontractors in performance of the construction work shall be paid wages at rates as required by Montana Prevailing Wage Rates. The Contractor must ensure that employees and applicants for employment are not discriminated against because of their race, color, religion, sex or national origin.

Each bid or proposal must be accompanied by a Certified Check, Cashier's Check, or Bid Bond payable to Lincoln County, in an amount not less than ten percent (10%) of the total amount of the bid. Successful Bidders shall furnish an approved Performance Bond and a Labor and Materials Payment Bond, each in the amount of one hundred percent (100%) of the contract amount. Insurance, as required, shall be

provided by the successful Bidder(s) and a certificate(s) of that insurance shall be provided.

This project is funded in part or in whole with grant/loan funding from American Rescue Plan Act (ARPA).

Award of the project will be contingent upon receiving funding and award concurrence from ARPA. Bids may only be withdrawn as provided in Section 15.03 of the Instructions to Bidders after the scheduled time for the public opening of bids.

The right is reserved to reject any or all proposals received, to waive informalities, to postpone the award of the contract for a period not to exceed sixty (60) days, and to accept the lowest responsive and responsible bid that is in the best interest of the Owner.
