## RESOLUTION 2025-07

### A Resolution Approving Troy Rural Fire District Loan Forgiveness

#### THE BOARD OF COUNTY COMMISSIONERS FOR LINCOLN COUNTY, MONTANA FINDS:

WHEREAS, the Troy Rural Fire District entered into a loan agreement for the amount of \$18,500, which was signed on August 8, 2022; and

WHEREAS, on August 7, 2021, the Lincoln County Administrator issued a fiscal year 2021/22 valuation letter totalling \$66,933.50 for the Troy Rural Fire District; and

WHEREAS, it has been determined that the valuation letter issued on August 7, 2021, contained an error regarding the amount of money that the Troy Rural Fire District would receive for the previous fiscal year; and

WHEREAS, the Board of County Commissioners and the Troy Rural Fire District Board discussed and agreed upon a reduced balance for repayment, which was recorded in the commissioner minutes of August 3, 2022, and in the Troy Rural Fire District Board minutes of August 25, 2022; and

WHEREAS, the agreed-upon balance of \$6,850 was paid by the Troy Rural Fire District via check #2570, dated February 1, 2023, and received by the County; and

#### NOW, THEREFORE, BE IT RESOLVED:

That the Lincoln County Board of Commissioners hereby forgives the remaining balance of the loan originally taken out by the Troy Rural Fire District in the amount of \$18,500, based on the payment of the agreed-upon balance of \$6,850 made on February 1, 2023, as documented by check #2570.

#### BE IT FURTHER RESOLVED:

That this forgiveness of the remaining loan balance is authorized retroactively to the date of the final payment, February 1, 2023, and any necessary adjustments to the loan amount and actions required to reconcile this matter shall be made accordingly.
