A Resolution to Amend a Parcel Precinct Boundary According to Troy City Limits THE BOARD OF COUNTY COMMISSIONERS FOR LINCOLN COUNTY, MONTANA FINDS:

- 1. Pursuant to Montana Code Annotated (MCA) Sections 13-3-101 and 13-3-102, the boundaries of voting precincts in Lincoln County may only be adjusted by resolution of the County Commissioners; and
- 2. The Election Administrator has identified a parcel of property within the Troy City limits that, based on legal description and city records, should not be included for election purposes; and
- 3. This parcel has been determined to be incorrectly included within the Troy City limits for voting purposes and needs to be reassigned to the correct precinct boundary:

T31NR34WS13 N2SE 1.11 ACRES 231 Sunrise Road Troy, MT 59935 Geo: 56-4280-13-3-09-02-0000 *3763*; and

4. This change will take effect immediately, and the updated precinct boundary will be reflected in the next election cycle.

THE BOARD RESOLVES:

That the Lincoln County Commissioners hereby approve the amended precinct boundary to reflect the correct jurisdiction for the aforementioned parcel, removing this property from the city limits for election purposes.



THE BOARD FURTHER RESOLVES:

- 1. If a provision of this resolution conflicts with a provision of a previously adopted resolution, this resolution will prevail.
- 2. This resolution and its various sections, clauses and paragraphs are severable. If any part, sentence, clause, or phrase is adjudged to be unconstitutional or invalid, the remainder of the resolution will not be affected.
- 3. This resolution will be effective immediately upon adoption, in accordance with § 7-5-123, MCA.
- 4. This Board directs that this resolution be entered into the minutes and signed by the Chair of the Board in accordance with § 7-5-121, MCA.
