## RESOLUTION 2025-12

### A Resolution to Amend Voting Precinct Boundaries Based on City of Troy Records

#### THE BOARD OF COUNTY COMMISSIONERS FOR LINCOLN COUNTY, MONTANA FINDS:

1. Pursuant to Montana Code Annotated (MCA) Sections 13-3-101 and 13-3-102, the boundaries of voting precincts in Lincoln County may only be adjusted by resolution of the County Commissioners; and
2. The Election Administrator has identified that the precinct boundaries referenced in a portion of Resolution 2023-13 were incorrect based on the legal description and city records.; and
