- Planning Project Contract MCR Grant Approval: Commissioner Teske noted an error by the state on the contract that Jesse brought to their attention. He advised this will be continued until it's corrected and returned.
- Emergency Services Boundary Modification: Commissioner Hammons advised the Troy Rural and Bull lake Fire Districts along with Sheriff Short met with emergency services to define a line for call out. **Motion** by Commissioner Hammons to approve the proposed boundary adjustments as outlined in the maps and direct the appropriate entities to update the official fire district boundary maps to reflect the change and authorize the installation of signage designating the revised district limits along the relevant public roadways. Second by Commissioner Duram. Discussion of the importance of maintaining clear lines with adjoining districts. No public comments. Motion carried.
- Update on GLID grant: Commissioner Duram noted a contract-change order had been received.

10:15 AM Public Comment Time - Non-Agenda Items: Present were Brian Berreman and Scott Shindledecker. None.

10:30 AM **Rural Propane Services Subdivision Extension Request:** Present were Alisha Osborne, Brian Berreman, Jesse Haag and Scott Shindledecker.

Alisha Osborne, Assistant Planner, presented a request of Rural Propane Services to extend the preliminary plat approval for one year. She described the subdivision details and recommended approving the 1-year extension to the preliminary approval of Rural Propane Services subdivision to expire May 18, 2026. **Motion** by Commissioner Duram to approve the extension request. Second by commissioner Hammons. Discussion of timeline. No public comments. Motion carried.

10:45 AM **Lincoln Electric Co-op-Funding Opportunities**: Present were Brian Berreman, Jacob DeLong and Jamie Stark.

Jacob DeLong, Lincoln Electric, advised Lincoln Electric Co-op was awarded a BRIC grant to put overhead power lines from the tunnel to the Trego substation underground and phase II, the construction, has been shut down. He stated they are obligated phase I funding of \$300,000 for design and procurement. He noted the estimated total project cost is \$7 million. They are seeking assistance through congressional direct spending opportunities to help with the project construction costs. Jamie Stark provided maps and advised 50-60 trains per day pass through the tunnel, and this is their single largest customer and load on their system. He provided site details and intent to convert nearly fourteen miles to underground for outage protection. Jacob requested Lincoln County champion this process with a letter of support for the \$6 million construction. Commissioner Duram advised congressional direct funding may be a way to get that funding and highlighted the BRIC status emphasizes the importance of this project. Discussion of keeping the project in the forefront as grant movement continues. **Motion** by Commissioner Duram to write a support letter for the Lincoln Electric Coop and to send to all four congressmen. Second by Commissioner Hammons. No public comment. Motion carried.
