A Resolution Annexing Little Bear Flats Subdivision and Six Tract Land Properties Into Troy Rural Fire District

THE BOARD OF COUNTY COMMISSIONERS FOR LINCOLN COUNTY, MONTANA FINDS:

- 1. On March 28, 2025, per MCA §7-33-2125 the trustees of the Troy Rural Fire District presented to the Clerk and Recorder's Office a request for annexation of the properties listed in petition #314877 and #314878 into the fire district: Ref attached maps; and
- 2. The property listed in the application has been verified as being within the proposed area for annexation and requirements pursuant to MCA §7-33-2125((1)(a) have been met; and
- 3. On April 9, 2025, the Lincoln County Board of Commissioners upon presentation of the petitions set a date for the public hearing; and
- 4. Pursuant to MCA §7-1-2121, a Notice of Public Hearing was published in the Kootenai Valley Record on April 23, 2025, and was posted on two courthouse public bulletin boards and county website under public notices; and
- 5. Pursuant to §7-33-2125 MCA, the Lincoln County Board of Commissioners held a Public Hearing on May 7, 2025, at 11:30 AM in the Commissioner's meeting room at 512 California Ave. Libby, MT 59923; and
- 6. MCA §7-33-2125(2) states, "On the date set for the hearing, the board of county commissioners shall consider the petition and any objections to the annexation. The board shall approve the annexation unless a protest petition signed by at least 40% of the owners of real property in the area proposed for annexation and owners of property representing 40% or more of the taxable value of the property in the area proposed for annexation is presented at the hearing, in which case the annexation must be disapproved; and
- 7. The County Commission did hear protests and public comments relating to the proposed annexation on May 7, 2025, and no protest petition was submitted.



THE BOARD RESOLVES:

The properties described herein as Little Bear Flats Subdivision PM 7259 and tract land listed in the petitions are annexed into the Troy Rural Fire District in accordance with MCA §7-33-2125.

THE BOARD FURTHER RESOLVES:


- 1. If a provision of this resolution conflicts with a provision of a previously adopted resolution, this resolution will prevail.
