A Resolution Annexing a Parcel Located at 29376 Bull Lake Rd into Troy Rural Fire District

THE BOARD OF COUNTY COMMISSIONERS FOR LINCOLN COUNTY, MONTANA FINDS:

1. The Board of County Commissioners of Lincoln County, Montana, received petition # 314876 for re-annexation of a parcel located at 29376 Bull Lake Road, Tax ID 6153 Geocode 56-4173-09-1-01-06-0000 into the Troy Rural Fire District, in accordance with MCA 7-33-2126; and
2. The Troy Rural Fire District has verified a willingness and ability to provide fire protection services, and the property owners wish to be included in the district; and
3. MCA 7-33-2126 allows a board of county commissioners to annex adjacent territory of an existing fire district upon the request of the property owners when it serves the best interest of the district and the property to be annexed; and
4. Annexing this parcel, which is closer to the Troy Rural Fire District, will enhance fire protection efficiency for both the area and the district; and
5. A public hearing on the petition was held on May 14, 2025, where no protests were heard. Per MCA 7-33-2126, the transfer must be allowed unless protests are presented at the hearing by the owners of 40% or more of the real property in either district and owners of property representing 40% or more of the taxable value in either district.
6. The County Commissioner did hear protests and public comments relating to the proposed re-annexation on May 14, 2025, and no protests were presented.

NOW, THEREFORE, BE IT RESOLVED:

The Board of County Commissioners of Lincoln County, Montana, hereby annexes 29376 Bull Lake Road, Tax ID 6153, into the Troy Rural Fire District. The parcel shall be subject to all taxes, assessments and fees associated with the Troy Rural Fire District as provided by law.
