RESOLUTION 2025-21

A Resolution to Amend Voting Precinct Boundaries Based on Town of Eureka Annexation Records

THE BOARD OF COUNTY COMMISSIONERS FOR LINCOLN COUNTY, MONTANA FINDS:

1. Pursuant to Sections 13-3-101 and 13-3-102 of the Montana Code Annotated (MCA), the boundaries of voting precincts in Lincoln County may be adjusted only by resolution of the Board of County Commissioners; and
2. The Lincoln County Election Administrator has identified a discrepancy in the existing precinct boundaries that does not reflect the current municipal boundaries of the Town of Eureka; and
3. The following parcels, for voting purposes, are located within the incorporated limits of the Town of Eureka and should be included in Precinct 4, consistent with Town records:
 - S14, T36N, R27W, Block 1 Lots 11 and 12, Midvale Addition Subdivision
Geo Code: 56-4823-14-1-11-12-0000
Tax ID: 7250
 - S14, T36N, R27W, Block 1, Lots 9 and 10, Midvale Addition Subdivision
Geo Code: 56-4823-14-1-11-10-0000
Tax ID: 7766

NOW, THEREFORE, BE IT RESOLVED:

By the Board of County Commissioners of Lincoln County, Montana, that the voting precinct boundaries are hereby amended to include the above-described parcels within the Town of Eureka Precinct 4, in accordance with the referenced legal descriptions and annexation records of the Town of Eureka.
