A Resolution to Set Elected Official Base Salaries

THE BOARD OF COUNTY COMMISSIONERS FOR LINCOLN COUNTY, MONTANA FINDS:

Whereas, pursuant to § 7-4-2503 and § 7-4-2504, MCA, which establish the salary schedule for certain county officers, require annual review by the county compensation board, and authorize the Board of County Commissioners to fix elected officials' salaries by resolution; and

Whereas, the Lincoln County Compensation Board met and approved a motion to award a 5% cost-of-living adjustment (COLA) to all elected officials.

NOW, THEREFORE, THE BOARD RESOLVES:

That the base annual salaries of the following elected officials, as verified by the Human Resources Department, shall be set effective July 1, 2025, as follows:

Clerk and Recorder	\$66,324.75	
Clerk of Court	\$66,324.75	
County Attorney	\$66,324.75	(portion paid by the county)
County Commissioner	\$68,324.75	
County Coroner	\$19,897.43	(set at 30% of Clerk & Recorder's salary)
Deputy County Coroner	\$5,969.23	(set at 30% of County Coroner's salary)
County Treasurer	\$66,324.75	
Sheriff	\$68,324.75	
Superintendent of Schools	\$66,324.75
