 - Kathi said that two part time employees have been hired for the animal shelter. The county took over the operation of the animal shelter on March 1st and they are working on getting contracts and policies in place. Operating Procedure #3 City-County Board of Health Lincoln County, MT October 2017

Purpose: The purpose of this document is to outline the procedures for handling requests for variances to Lincoln County's Health and Environment Regulations.

The following Procedures apply to the City-County Board of Health (Board) and any committees thereof.

General Requirements:

- A person who owns or is in control of a property subject to Health and Environment Regulations may apply to the Board for a variance.
- The Board may grant or renew a variance if it finds:
 - 1. A variance from a requirement of these regulations does not conflict with state or federal law;
 - 2. The variance does not create a danger to public health or safety; and
 - 3. Compliance with the regulation from which a variance is sought would produce hardship without equal or greater benefit to the public.
- The Board may place conditions on a variance and the person subject to the variance shall adhere to those conditions. Failure to adhere to the conditions is cause for revocation of the variance and other appropriate legal action.
- Variances are non-transferable and remain valid only for the applicant to whom they are granted.

Application:

- An application for a variance may be in the form of a letter and must contain the following information:
 - 1. Applicant's name, address and contact information;
 - 2. Specific regulation and provision from which a variance is requested;
 - 3. Legal description or address of property where variance would apply;
 - 4. Detailed and accurate description of the circumstances under consideration, including an explanation of why compliance is not justified and description of alternatives considered;
 - 5. Any other relevant information that the department or Board may require.
- The application will be submitted to the Lincoln County Health Department (Department).

Decision:

- The Department may grant a temporary variance for up to ninety (90) days.
- The Department will forward the application to the Board with their advisory opinion.
- The application will be considered at the Board's next regularly scheduled meeting, provided that the application is received at least fourteen (14) days prior to the scheduled meeting date. At this meeting, the applicant may appear in person or be represented by another person.
- The Board will make a final decision within thirty (30) days following the hearing, unless it notifies the applicant that more time is needed.
- The final decision must be in writing and signed by the chair of the Board.



The proposed Elevated Sand Mound (ESM) does not meet the 10' setback requirements from the property boundary per ARM 17.36.323 Setbacks. The ESM is 2' from the property boundary to the west and 2' from the property boundary on Glen Lake Drive. The Right of Way setback for Glen Lake Drive is 60' and if the variance is approved, the Road Department will need to approve the proposed installation on the Right of Way. The ESM is to replace the two illegal systems on the property and does meet the 100' setback from the lake and is out of the 100' well isolation zone. Environmental Health supports the variance request because it meets the well and lake shore setbacks, is replacing two illegal systems, public and environmental health are not at risk, and it appears that no other location on the property is available.

RE: Libby Asbestos Superfund Site

Dear Sir:

We have recently learned that the EPA determined in their 2025 Five Year Review (FYR) that the remedy for the Libby Asbestos Superfund Site (Site) is still "protective". We strongly disagree and support the concerns raised in the Libby Asbestos Superfund Oversight Committee (LASOC) letter dated June 27, 2025. Additional information since the last FYR clearly indicates that protectiveness cannot be determined until further information is obtained (consistent with EPA Guidance).

The Position Statement adopted in January 2018 by both the Board of Health and the Lincoln County Commissioners includes a core element that protection of human health and the environment will serve as the universal criterion for judging actions and activities at the Site. That Position remains and guides us, and we can no longer assure the public that the remedy is protective, but rather that now protectiveness can no longer be determined.

We expect to provide additional comment on the FYR report.
