#### Recording & Document Fees

#### Effective October 1, 2025

Pursuant to House Bill 192 (69th Legislature, 2025) and amendments to MCA §§ 7-4-2632, 7-4-2635, and 7-4-2637, recording fees for documents filed with the County Clerk and Recorder will increase as follows:

## \$20 for the first page or fraction of a page & \$10 for each additional page or fraction of a page

Starting July 1, 2027, fees and allocations will be adjusted biennially for inflation.

The Lincoln County Clerk & Recorder offers services for recording documents, plat maps, surveys, tax liens and provides certified copies of previously recorded documents. All fees must be paid in advance of services rendered. Payment by cash, money order or check payable to the Clerk & Recorder.

#### Electronic Recording (ERecording) is available in Lincoln County, Montana through Simplifile.

Lincoln County uses Simplifile to eRecord documents online. To get started contact Simplifile at 800.460.5657 and speak to a representative.

Documents must have a three-inch (3") top margin and a return address in the upper-left corner to avoid the nonstandard fee.

Documents that do not meet Montana's formatting standards are subject to a \$10.00 additional fee per document. See MCA § 7-4-2637(2) for formatting requirements.
