## RESOLUTION 2026-01

### A Resolution Establishing Regular Meeting Dates of the Lincoln County Board of Commissioners and Electing a Presiding Officer for the Ensuing Year

#### THE BOARD OF COUNTY COMMISSIONERS FOR LINCOLN COUNTY, MONTANA FINDS:

**Whereas**, MCA 7-5-2122 requires the board of county commissioners to establish by resolution a regular meeting date and notify the public of that date; and

**Whereas**, except as provided in MCA 7-5-2122(3) or in the event of an emergency under MCA 2-3-112, all meetings must be held on the regularly established date and at the county seat; and

**Whereas**, MCA 7-4-2109 requires the board of county commissioners to elect one of its members as the presiding officer to preside at all meetings of the board, and in case of the presiding officer's absence or inability to act, the members present shall select one of their number to act temporarily as presiding officer.

#### NOW, THEREFORE, BE IT RESOLVED:

##### 1. Regular Meeting Date and Location

The Lincoln County Board of Commissioners hereby establishes **each Wednesday** as the regular meeting date of the Board. Regular meetings shall be held at the Lincoln County Courthouse in Libby, Montana, **except that the third Wednesday of each month** is scheduled to be held at the Eureka Annex, unless otherwise changed by resolution with at least two days' posted public notice in accordance with MCA 7-1-2123.

##### 2. Presiding Officer

The Lincoln County Board of Commissioners hereby elects Brent Teske as the Presiding Officer of the Board for the year 2026.

## THE BOARD FURTHER RESOLVES:

1. If a provision of this resolution conflicts with a provision of a previously adopted resolution, this resolution will prevail.
