A Resolution Establishing Locations for Posting Public Notice

THE BOARD OF COUNTY COMMISSIONERS FOR LINCOLN COUNTY, MONTANA FINDS:

Whereas, MCA § 7-1-2121 establishes requirements when public notice is to be provided by publication; and

Whereas, MCA § 7-1-2122 establishes requirements when public notice is to be provided by mail; and

Whereas, MCA § 7-1-2123 establishes requirements when public notice is to be provided by posting, including that the governing body shall specify by resolution a public location for posting information; and

Whereas, MCA § 7-1-2123(2) further requires that when posting is required, a copy of the document must be placed on the posting board and a copy must also be available at the Office of the County Clerk and Recorder.

NOW, THEREFORE, BE IT RESOLVED:

1. Official Posting Locations

Lincoln County hereby designates the following locations as the official posting boards for public notices required under MCA § 7-1-2123:

- The bulletin boards located at the southeast and northeast entrances on the main floor of the Libby Courthouse; and
- The public bulletin board in the main business office at the Eureka Annex.

In addition, the County may also publish required notices on the County's official website as a supplemental posting in addition to physical posting.

2. Clerk & Recorder Copy Availability

For any notices required to be posted under MCA § 7-1-2123, a copy shall be available for public inspection at the Office of the Lincoln County Clerk and Recorder.
