

**NOTICE OF PUBLIC HEARING  
LINCOLN COUNTY HEALTH DEPARTMENT FEE SCHEDULE**

Notice is hereby given that the Lincoln County Board of County Commissioners will hold a **public hearing on April 8, 2026, at 10:15 a.m.** in the Lincoln County Courthouse, Libby, MT, to consider Resolution 2026-11 to adopt a revised Health Department Fee Schedule.

The proposed revisions include updates to plan review fees, inspection fees, septic and wastewater permit fees, variance application fees, and licensed installer fees, as well as the establishment of a \$500.00 Multi-User Wastewater Application fee. The revisions incorporate changes required by House Bill 853, enacted by the 2025 Montana Legislature, which established new environmental health fee structures and service categories and requires counties to update their local fee schedules.

All interested persons will be given an opportunity to be heard.
