**THE BOARD OF COUNTY COMMISSIONERS FOR LINCOLN COUNTY,
MONTANA FINDS:**

WHEREAS, the Board of County Commissioners for Lincoln County, Montana previously adopted Resolution 2026-07 Authorize Running the Special Purpose District Election; and

WHEREAS, the Libby Park District has notified the County that it no longer wishes to hold a Special Purpose Election; and

WHEREAS, The Board finds it in the best interest of Lincoln County to rescind Resolution 2026-07.

NOW, THEREFORE, BE IT RESOLVED:

1. Resolution 2026-07 Authorize Running the Special Purpose District Election is hereby rescinded in its entirety.
2. This Resolution shall be in full force and effect immediately upon its adoption
