A Resolution Adopting an Updated Lincoln County Health Department Fee Schedule

THE BOARD OF COUNTY COMMISSIONERS FOR LINCOLN COUNTY, MONTANA FINDS:

WHEREAS, the Lincoln County Board of Commissioners recognizes the importance of protecting public health and ensuring compliance with state sanitation, food safety and wastewater regulations pursuant to its general powers under MCA § 7-1-2103 and its authority under MCA Title 50; and

WHEREAS, the Lincoln County Health Department administers and enforces state and local regulations governing food establishments, temporary food services, mobile food units, public accommodations, wastewater treatment systems, subdivisions and licensed installer programs; and

WHEREAS, the 2025 Montana Legislature passed House Bill 853 creating new fee structures and categories for licensed establishments, requiring counties to adopt updated fees to cover the cost of plan reviews, pre-opening inspections and associated regulatory services; and

WHEREAS, the existing Health Department fee schedule no longer reflects the actual cost of providing plan review, inspection, variance review, wastewater permitting, licensed installer oversight, subdivision review and related administrative services; and

WHEREAS, the Board has reviewed workload data demonstrating increased variance requests, wastewater applications and subdivision-related reviews requiring significant staff time and technical evaluation; and

WHEREAS, the Board finds it necessary and appropriate to revise the Health Department Fee Schedule to ensure fees are reasonably related to the cost of providing services and to maintain effective public health protections for the residents of Lincoln County; and

WHEREAS, the Board adopted a Resolution of Intent to adopt the revised Health Department Fee Schedule on March 11, 2026; and

WHEREAS, notice of a public hearing was duly published and a public hearing was held on April 8, 2026, at 10:15 a.m. in the Commissioners' Chambers, Lincoln County Courthouse, Libby, Montana, at which time the public was given the opportunity to comment on the proposed fee schedule.

NOW, THEREFORE, BE IT RESOLVED:

that the Lincoln County Board of County Commissioners hereby adopts the Lincoln County Health Department Fee Schedule as set forth herein. The Board finds the fees reasonably related to the cost of providing public health regulatory services.
